

Bank of Bhutan would like to invite sealed bid from the registered national firms with the valid trade license to participate for supply, delivery and refill of fire extinguisher gas/powder and smoke detector batteries.

LOT II: Smoke Detector Batteries

I. Duracell Ultra Lithium: 123 Lithium, 3V CR17345, DL123, EL123.

OWNERSHIP OF THIS STANDARD BIDDING DOCUMENT (SBD)

▪ **DUE DILIGENCE**

The bid shall be deemed to have been submitted after careful study and examination of this SBD. The bid should be precise, complete and in the prescribed format as per the requirement of this SBD document. Failure to furnish all information or submission of a bid not in-line with this SBD will be at the bidders' risk and shall result in rejection of the bid. Also, the grounds for rejection of Bid should not be questioned after the final declaration of the successful Bidder.

The bidder is requested to carefully examine the SBD and the terms and conditions specified therein and if there appears to be any ambiguity, contradictions, inconsistency, gap and/or discrepancy in the SBD, Bidder should seek necessary clarification.

TERMS AND CONDITIONS OF SBD

1. Scope of Supply

- 1.1. The bidder(s) price quoted shall be as per the technical specification mentioned above and the Price Schedule as attached at **Annexure -II**.

2. Clarification to the bidding document

- 2.1. Further information can be obtained in writing from Procurement Division **OR** email to dupchen.lepcha@bob.bt and kinga.tshering2682@bob.bt not later than five calendar days from the date of bid submission. Clarification received after the deadline shall not be entertained.

3. Documents comprising bid

- 3.1. The bid must be accompanied by the following document:
- i. Bid Security;
 - ii. Valid Trade license;
 - iii. Tax clearance;
 - iv. Bid Submission Form in Annexure I;
 - v. Price Schedule in Annexure II; and

4. Bid Price

- 4.1. The quoted price shall in Ngultrum. The quoted price shall be in Delivery Duty Paid (DDP), Thimphu, including taxes, duties and other levies to the final place of delivery.
- 4.2. The final place of delivery of fire extinguisher gas refill and smoke detector batteries is at BoB Corporate Office, Norzin Lam, Thimphu.

5. Bid Validity

- 5.1. The bid shall be valid for **60 calendar days** from the date of submission of the bid. In exceptional circumstances, prior to the expiration of the bid validity period, the Purchaser may solicit the Bidder's consent to an extension of the bid validity period. The request and responses shall be made in writing. A bid valid for a shorter period shall be considered non-responsive.

6. Bid Security

- 6.1. The bid shall be accompanied by a bid security in the form of Cash Warrant/Unconditional Bank Guarantee/Banker's Cheque/Demand draft in the name of the **Bank of Bhutan** issued by the Financial Institution enforceable in any Banks in Bhutan. The amounts are as below;

LOT I (Fire Extinguisher Gas/Powder Refill)- Nu. 10,000.00 and

LOT II (Smoke Detector Batteries) – Nu. 5,000.00

(Note: if the bidder wishes to quoted both the lots, the total EMD is Nu. 15,000.00)

- a) The Bid security shall be valid for 3 months beyond the date of submission.
 - b) The Bid Security is to be submitted as a part of the Bid along with the bidding document.
 - c) Any Bid not accompanied by bid security of adequate value and validity shall be rejected by the Purchaser as non-responsive.
- 6.2. The bid security shall be forfeited in the following cases:
- a) If the Bidder withdraws the bid after Bid opening during the period of Bid validity.
 - b) If the Bidder does not accept the correction of the Bid price;
 - c) In the case of a successful bidder, if the bidder fails within the specified time limit to sign the Contract or furnish Performance Security.

7. Submission of Bids

- 7.1. The bidder(s) shall submit one original bid and clearly marked "**ORIGINAL**". In addition, the bidder(s) should also submit one copy marked as "**COPY**". Bid submitted in electronic means are not acceptable. The bid including all documents should be duly filled, signed and sealed in an envelope and addressed to and delivered at the following address;

8. Submission deadline

- 8.1. The deadline for receipt of your bid(s) and other required documents as per clause 3 of the above by the Purchaser at the indicated is on or before 4th July 2022 at 2:30 PM (BST). Late submission of bid(s) shall not be entertained.

9. Bid Opening

- 9.1 The bid(s) will be opened in the presence of bidders or their representatives who choose to attend on 4th July 2022 at 3:00 PM (BST).

In case due date of the opening of the bid falls on non-working days, the opening of the bid shall be on next working day at the same time.

10. Evaluation of Bid

- i. Evaluation shall carry out lot wise.
 - ii. To assist in the examination, evaluation and comparison of bids, the client may, at its discretion, ask the Bidder for a clarification of its Bid. All responses to requests for clarification shall be in writing, and no change in the price or substances of the Bid shall be sought, offered or permitted. Failing to respond to the clarifications sought by the client within two working days will be treated as non-responsive and hence be rejected.
 - iii. Non-compliance with the technical/product specification shall be considered as non-responsive bid and shall not be evaluated.
 - iv. Bidders' bid complied with the technical specification of the LOT I and LOT II shall be evaluated based on the quoted price of the products
- b. **while evaluating the quotations, the Bank will determine for each quotation and evaluate price by adjusting the quoted price in case there is any arithmetical errors as follows:**
- i. Where there is a discrepancy between amounts in figures and in words, the amount in words will prevail;
 - ii. Where there is discrepancy between the Unit Rate and the line item, the resulting figure from multiplying the Unit Rate by the quantity shall prevail unless in the opinion of the Bank there is an obviously gross misplacement of the decimal point in the Unit Rate; and
 - iii. If the supplier refuses to accept the correction, this quotation will be rejected and the bid security shall be forfeited.

11. Purchaser's Right to Accept Any Bid, and Reject or Cancel Any or All Bids

- 11.1. The Purchaser is not bound to accept the lowest bid and reserves the right to accept or reject or cancel any or all the bids without assigning any reason whatsoever.

12. Quantity Variation

- 12.1. Depending on the final requirement, at the time of the award of the Contract, the Purchaser may increase or decrease the quantities by twenty five percent (25%) of the indicated quantity.

13. Award of Contract

- 13.1. The Purchaser shall award the Contract to the Bidder whose offer has been determined to be the lowest evaluated Bid. The Purchaser shall issue Notification of Award/ Purchase Order to the successful Bidder.
- 13.2. Item shall be evaluated in lot wise and contract shall be awarded to the bidder offering the lowest evaluated bid.

14. Delivery and Installation Schedule

- 14.1. The supply and delivery of the Goods and related service shall be completed within;
- a. **45 Calendar days** fire extinguisher gas refill from the date of purchase order.
 - b. **20 Calendar days** for smoke detector batteries from the date of purchase order.

- 14.2 Supply and Delivery: Corporate Head Office, Norzin Lam, Thimphu

15. Performance Security

- 15.1. The Supplier shall be required to furnish Performance Security of 10% of the quoted price in the form of cash warrant/demand draft/Banker's Cheque or unconditional Bank Guarantee in the name **Bank of Bhutan** issued by a financial institution enforceable in any Banks in Bhutan, which shall be furnished upon issuance of notification of the award. Performance Security shall be valid of six months and will be returned after the completion of supply.
- 15.2. The performance security shall be forfeited in the following case, if the bidders:
- i. Fails/withdraws to perform the contractual obligation under the purchase order/contract agreement;
 - ii. Supplied different product which is not as per the specification/supplied inferior products and

iii. Fails to replace the defective goods within 21 calendar days after notifying.

16. Liquidated Damage

16.1. If the Supplier fails to deliver any or all of the Goods by the date(s) of delivery or fails to perform the Related Services within the period specified in the Contract/ Purchase Order, the Purchaser shall deduct Liquidated Damages at the rate of **0.3%** per day for each day of delay to a maximum of **10%** of the quoted price.

17. FORCE MAJEURE

- a) The Supplier shall not be liable for forfeiture of its Performance Security, liquidated damages or termination for default if and to the extent that its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.
- b) For purposes of this Clause, "Force Majeure" means an event or situation beyond the control of the Supplier that is not foreseeable, is unavoidable, and its origin is not due to negligence or lack of care on the part of the Supplier. Such events may include, but not be limited to, acts of the Purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- c) If a Force Majeure situation arises, the Supplier shall promptly notify the Purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

18. Payment Terms

- 18.1. No advance payment shall be made prior to the completion of project and the payment will be made within 30 working days after submitting the invoices.
- 18.2. At the time of release of payment, Tax shall be Deducted at Source [TDS] from the gross amount of bills as per the Income Tax Act of the Bhutan.

19. Warranty Period

- 19.1. Minimum warranty period of the goods is one year from the date of supply. Any goods found defective/fault during the warranty period has to be replaced/repaired by the supplier at his own cost.

19.2. If the supplier fails to rectify and or replace the defective goods, the performance security shall be used to cover the cost of supplies not delivered or defective items not replaced or rectified.

20. Submission of Bid

20.1. The Bidder shall submit the Bid Submission Form using the Form in the **Annexure I**: This form must be completed without any alterations to its content. All blank spaces shall be filled in with the information requested.

20.2. A bid in which the Bid Submission Form not duly filled, signed and sealed by the bidder shall be rejected.

21. Termination

21.1. The Purchaser may, by written notice, terminate the Purchase Order or Contract [if applicable] in whole or in part at any time for its convenience:

21.2. If the Supplier fails to perform any other terms and conditions specified with the Purchase Order/Contract, or exceeds the maximum amount of Liquidated Damages; and

21.3. If the Supplier does not take any remedial action of the default within a given time period after notifying by the Purchaser.

22. Governing Law

22.1. The Contract/ Purchase Order shall be governed by and interpreted in accordance with the Laws of Bhutan.

23. Dispute Resolution

23.1. Any settlement of dispute or arbitration of matter arising from the contract shall be settled as per the Alternative Dispute Resolution Act of Bhutan 2013.
