- Trade confirmation Certificate from concerned broker (in case of pledge financing). Trade confirmation Certificate to be submitted after confirming trade in case of purchase financing;
- Copy of ownership certificate(s) of the mortgage offered to the bank;
- Consent letter from the joint owner if the mortgage provided is in joint ownership;
- For family owned land, family tree issued by Department of Civil Registration and Census, and NOC from family members (18 years and above) (if applicable).
- Valid insurance copy of the mortgage charged in case of building;
- Dividend declared by the company for the any past three years in case of pledge financing (available in RSEBL website or can contact the BOBL broker); and
- Proof of income to service the loan repayment.
